Fourth, teams must abide by the project accredited schedule,


Fifth, this decision abolishes other previous contradictory decisions in this regard,

- 3) Writing detailed reports on each institutional standard after the completion of the aforementioned tasks (1-2), that each team shall be concerned with the relevant domain standards.
- 4) Preparation of documents for each NCAAA institutional accreditation standard that each team shall be concerned with the relevant domain standards.
- 5) Examining and commenting on the independent opinion report that each team shall be concerned with the relevant domain standards.
- 6) Replying to NCAAA reports during the project period that each team shall reply to the reports of the relevant domain standards.

- 3. Contacting the various University units to complete data, information and performance indicators in the self-study.
- 4. Final preparation of documents used in preparing self-study at the institutional level of Najran University in coordination with the committees from A-H.

• Responsibilities of Committee of Information and Documentation

- 1- Providing data, information and official documents of subcommittees and self-study team, as well as validating of data and standardization of source.
- 2- Following up the website of receiving documents and information from colleges, programs and units and submitting periodic reports thereon.
- 3- Paper and electronic documentation of self-study documents and touchstones.
- 4- Participating in the preparation and processing of documents room in student sections.

• Responsibilities of Reception and Information Committee

- 1- Design of a media plan to cover events, workshops and field visit of external reviewers team
- 2- Media coverage of the university institutional accreditation project with all possible means.
- 3- Participation in the implementation of reception and hospitality protocols, all kinds of logistic support during audit and technical support visits, holding workshops and other activities of institutional accreditation project.
